FELONY COMPLAINT

**COUNT 1**

The undersigned, under penalty of perjury upon information and belief, declares: That the above named defendant(s) JAKE MITCHELL HARO and REBECCA RENEE HARO committed a violation of Penal Code section 187, subdivision (a), a felony, in that on or about August 05, 2025 through and including August 14, 2025, in the County of Riverside, State of California, the defendant(s) did willfully and unlawfully murder BABY DOE (E.H.), a human being. ## COUNT 2

That the above named defendant(s) JAKE MITCHELL HARO and REBECCA RENEE HARO committed a violation of Penal Code section 148.5, subdivision (a), a misdemeanor, in that on or about August 14, 2025, in the County of Riverside, State of California, the defendant(s) did willfully and unlawfully report to a police officer, deputy sheriff, and member of the California Highway Patrol that a felony and misdemeanor has been committed knowing that report to be false. ## 1109 NOTICE

Pursuant to section 1109 of the Evidence Code, evidence of the defendant's commission of other acts of domestic violence may be admissible at trial in a criminal action in which the defendant(s) is/are accused of an offense involving domestic violence.
