73. Narrative Continued from Supp report dated 05/05/2010.  On <u>05/04/2010</u> the u/s officer <u>did meet with Mr. Alexis Diaz (victim's boyfriend)</u> at the Jersey City Police dept., Missing Persons Unit in reference to above reported missing person, Shannon Maria Gilbert. Shannon was reported missing to the Jersey City Police Dept on <u>05/04/2010</u> at approximately <u>0050 hrs.</u> She was reportedly last seen on <u>05/01/2010</u> at approx. <u>0600 hrs</u> in the area of <u>8 Fairway, Oak Beach, New York, 11702.</u> This incident is also documented by the Village of <u>Ellenville, New York, Police Dept.</u> under Incident No <u>10-3972</u> and the Suffolk County Police, Marine Bureau, in the Hamlet of Oak Beach under Field Reports with Central Complaint #'s <u>10-210035, Dated 05/01/2010 @ 0520 hrs., 10-213581, Dated 05/02/2010 @ 1921 hrs., and 10-214997, Dated 05/03/2010 @ 1321 hrs.</u>  Mr. Diaz indicated to the u/s that he has been aware of Shannon's involvement in the "Escort" business and has been dating her since Dec., 2007. He also states that Shannon uses CDS (cocaine and marijuana) and drinks (Vodka) while she is out on her "dates". Mr. Diaz states that on Friday, April 30th, 2010 at approximately 2000 hours, Shannon left their apt. at 159 Christopher Columbus Dr and was going to take the Path to 34th St in New York City where she was to be picked up by her driver, Mike Pak, and taken to the residence of a man named Joe Brewer, whom she met through "Craigs List". She was driven to Mr. Brewer's residence by Mike and did not return home that morning (Sat. 05/01/2010). He and the family subsequently contacted Mike who had not reached out to Alex to let him know of the problem that had occurred at Joe Brewer's residence on the morning of May 1st. He

Gilbert on Friday April 30, 2010 at approximately 2000 hrs. Mr Diaz described Ms. Gilbert as white, 5'-7", 124 lbs. brown eyes, pierced nose, a tattoo of cherries on her left wrist, a tattoo of a scorpion on her back, a small scar under her right eye, and having long blonde hair. Ms Gilbert was last seen wearing a brown leather jacket, blue jeans, black strappy sandals, long gold colored hoop earrings, a white metal ring, and a multi stoned bracelet. He said she was on her way to an escort job in Ellenville, NY. Ms. Gilbert was picked up in a car by a male known only to him as Mike. He could only describe Mike as an Asian man. He furnished the undersigned with an address of 133-01 Booth Memorial Ave. Flushing, Queens 11355 and telephone number of 645-342-1405. Mr. Diaz said Mike is Ms. Gilbert's business partner and driver. Mr. Diaz spoke with Mike on Sunday May 2, 2010 at approximately 1400 hrs. Mike told him that he last saw MS. Gilbert running out of the client's home on Friday. Mike said the client was Tom Brewer of 8 The Fairway, Oak Beach, NY. Mike told Mr. Diaz that she was hysterical and screaming. She was knocking on doors in the neighborhood. He approached her and took her cell phone from her when she told him she was going to call police. Mike told Mr. Diaz that he left the location without Ms. Gilbert.

Mr. Diaz also informed the undersigned that Ms. Gilbert probably uses cocaine and is bipolar. He gave two photos of the Ms. Gilbert. He said she also has a second cell phone, (917-420-8977) and gave her mother Marie Gilbert's cell phone (845-332-5557).
