contacted Mike who stated that he had last seen Shannon on Saturday morning (05/01/10) at about 0600 hours after she left Joe Brewer's house running through the neighborhood screaming and yelling. Mike told Alex that he "thought " that Alex had returned home because she had refused to get into his vehicle and he finally left Oak Beach.

The u/s then contacted Michael Pak (aka Mike) via phone at 646-342-1405. Mike states that he provides a car service and drives girls to "dates" and gets paid through an account he has set up with Craig's List. He also states that he receives a "commission" for every client that he takes on a date. For example if a girl gets \$ 200.00, he receives \$ 50.00. He also provided the u/s with a Boost Mobile phone # 017-420-8977 that is used by the "clients". Mike has drive Shannon to numerous "dates". He states that on 05/01/2010, he picked Shannon up in Midtown and drove her to the residence of Joe Brewer at 8 Fairway, Oak Beach, N.Y. He dropped Shannon off at Brewer's residence at approximately 0100 hrs. and waited for her outside. While he waited he observed Joe Brewer and Shannon leave the house for a short period of time and then return. Shannon subsequently called him via phone and advised him that she would be extending the session with Joe Brewer. At approximately 0430-0500 Joe Brewer came out of the house and told him that he had to come and get "his girl" because she was freaking out. He went into the residence, which he described as very messy and unkempt, and attempted to get Shannon to leave. She was hiding behind the furniture acting very strangely and saying something to the effect that she knew that they were trying to kill her. Shannon continued to act in a paranoid manner and ran out of the house. He states that Joe went upstairs Shannon ran out of the house falling on the darkened steps. Mike states that he continued to follow Shannon around the development, which is a gated community while she ran from residence to residence knocking on different doors and yelling incoherently. Mike states that he followed Shannon through the development and at somewhere between 0530 hours and 0600 hours he lost sight of her behind some homes. When she did not reappear he assumed that somehow she had found her way out of the development and found her way home. At that point he left Oak beach and returned home. He had not been aware that Shannon had not returned home until he was contacted by Alex and her family on Sunday, 05/02/2010. (It should be noted that during my previous conversation with Officer Stevens of the Suffolk Co. P.D., Marine Unit, I was provided with the copy of a Field Report reference to a disturbance complaint. At approximately 0520 hours a call was placed to the Suffolk County Police Dept. By Mr. Gus Coletti of a blonde woman running on the street yelling (Fairway & Galley). Officers responded and arrived at 0540 hours and spoke with the complainant. All of Oak beach was searched with negative results. Field Report generated # 10-210035.
